Who needs to file a financial disclosure?	This form is to be filled out by all Legislative Commissioners, Governors' Appointees, and their proxies.
What is the purpose of a financial disclosure?	The intent of this form is to provide a disclosure of direct and indirect financial interests that may impede the ability of a Legislative Commissioner, Governor Appointee, or and proxy to execute his/her duties in a fair and impartial manner. Completed forms will be published on the Commission website (on the Commissioner page) and made available at meetings.
What must I disclose on this form?	The form collects basic information on the broad category of financial interest. It will not collect specific dollar amounts of investments or holdings.
When do I need to complete my financial disclosure?	A completed disclosure form must be submitted to the Commission prior to participating in a Commission meeting. If this form is for a proxy, the appointing Legislative Commissioner or Governor Appointee and the proxy must sign the form and return it to the Commission by <b>February 1</b> <sup>st</sup> <b>of each year</b> . For appointments made after February 1 <sup>st</sup> , a completed disclosure form must be submitted to the Commission prior to Commissioner/proxy participation at the next schedule Commission meeting.
	Disclosure Forms must be submitted annually. If there are no changes, the previous year's form can be resubmitted.
What else is required if I appoint a proxy?	In addition to submitting a <u>Proxy Form</u> and ensuring your proxy submits a Disclosure Form, you are required to notify your home state's appointing authority when such a proxy appointment occurs. The notification must include a copy of the proxy's Disclosure Form. A copy of this notification must be supplied to the Commission's Executive Director.
