

Background



- October 2018
 - Implementation of Tagging Program postponed until January 1,2020
- Fall 2019
 - States submitted biological metric in September
 - Tags and applicators were ordered by ASMFC Staff
 - All states received orders by December 2019
- Implementation was expected for many states starting January 2020

2020 Update



- States do not need to reimburse ASMFC for 2020 tags
- March: COVID-19 pandemic delayed implementation for many states
 - state by state details provided in memo
- April and May
 - NY and CT decided to postpone implementation until 2021

Planning for 2021 Tagging Program



- Designate state contact for ordering Tags & Applicators
- Develop plan for distributing tags
 - COVID-19 challenges may persist
- Biological metric (# of tags and methodology)
 - Estimate of tags needed in a few weeks
- Orders should be placed by Oct 1
- Unused 2020 tags need to be collected by <u>Feb</u>
 15, 2021
- '21 Tags will be the same design w/year updated

For Board Consideration



- NY is requesting to use 2020 tags for next year
 - Conflicts with Amendment 1 language; Board approved needed

LEC Feedback

- With early enough notice, no problem
- Should be an exception, not precedent setting
- Tag accounting in other states will be important


If the Board approves, LEC should be notified well in advance of 2021 fishing season
