
#### Status of the Stocks

- American shad: 2007 Benchmark Stock
   Assessment stocks are currently at all time lows and do not appear to be recovering
- Hickory shad: status unknown
- River Herring: 2012 Benchmark Stock
   Assessment depleted






## **Shad Commercial Landings**

## **Coastwide Stocking**

Occurring in ME, MA, PA, NC, SC

American shad: 16 million

Alewife: 400,000





## **Sturgeon Interactions**

297 interactions were reported

• CT, NJ, VA, SC, GA

All released alive.





#### **PRT Recommendations**

- Several of the states did not report all of the monitoring requirements listed under Amendments 2 and 3.
  - The states should take note of the required monitoring programs that were not reported and make concerted effort to report all monitoring programs





#### Recommendations

- The PRT requests the Board task the TC with the following:
  - Review of recreational compliance and the ability of states to provide recreational data. A majority of states rely on MRIP for catch estimates and do not have survey data of their own.
  - Review methods to ensure states submit data that were previously unavailable (if a state is still completing sampling when the compliance report is turned in, a follow-up version should be sent when the sampling is completed).

## **Habitat Plan Background**

- Amendment 3 required states to submit a habitat plan
  - Current and historical spawning and nursery habitat
  - Threats to those habitats
  - Habitat restoration programs





#### **Technical Committee Review**

- TC held a conference call to review plans
- 18 members on call
- Plans received from every state with an interest in Shad FMP except Hudson and Merrimack Rivers and Florida
  - Florida anticipates plan completed in March, due to necessity to coordinate with other state agencies
  - Hudson River and Merrimack have an unclear final date



#### **Trends in Plans**

- Largest threat coastwide are barriers to migration
- Overall lack of information on potential impacts of climate change





#### TC Recommendations

- Made recommendations to states based on discussion during call
  - Final plans were due January 10, 2014
- TC recommends approval of all habitat plans that have been received
  - Requests receipt of missing plans ASAP for review

### **Recent Council Actions**

### Amendment 5 to the Atlantic Herring FMP

- Comprehensive catch monitoring program
- River herring monitoring/avoidance measures
- Formal support for SMAST/SFC/MA DMF project
- RH/S catch caps to be established through FWA
- Final Rule/implementation imminent

#### \*Framework 3 to the Atlantic Herring FMP

- RH/S catch caps process and related provisions
- 2014/2015 RH/S catch cap specifications
- Final measures selected November 2013; submission January 2014; implementation ASAP

### **Recent Council Actions**

#### Framework 4 to the Atlantic Herring FMP

- Disapproved elements of Amendment 5 dealer weighing provisions, measures to address slippage
- Initial meeting January 2014; Final Meeting April 2014; submission June/July; implementation ASAP

# Omnibus Industry-Funded Monitoring Amendment (NMFS)

- Disapproved elements of Amendment 5 observer coverage provisions, industry-funded monitoring
- Provisions for industry-funded monitoring in all FMPs; herring/mackerel observer coverage measures
- Implementation ASAP

## MAFMC (Atlantic Mackerel FMP)

- Am14 established RH/S catch cap provisions
- 2014 specifications specified RH/S catch cap for mackerel fishery (236 mt)
- RH/S cap will apply to all trips landing more than 20,000 pounds of mackerel in all areas
- Proposed Rule published, Final Rule/implementation ASAP (March 2014)
- 2015 mackerel fishery catch cap will be considered during 2014

## MAFMC (Mackerel FMP)

#### Framework 9 to the Atlantic Mackerel FMP

- Measures to address net slippage (disapproved in Amendment 14)
- Final measures selected in February 2014

#### RH/S Committee and FMAT

- MAFMC, NEFMC, ASMFC, with an AP and FMAT
- Initial focus on improving basis/effectiveness of RH/S catch caps
- Will develop more specific TORs at first meeting


Both Councils will be participating with NMFS and ASMFC on the TEWG to implement a comprehensive, coastwide effort to conserve river herring and address data gaps.

## Fw 3 – RH/S Catch Cap Provisions

- Caps apply collectively to four species of river herring and shad (RH/S) on trips landing more than 6,600 pounds (3 mt) Atlantic herring
- Annual catch caps distributed by gear/statistical area clusters
- When a catch cap is reached in an area, directed herring fishery closes in the associated closure area (offshore portions of SNE/MA remain open)

## Proposed RH/S Catch Cap Areas


RH/S catch from all trips landing more than 6,600 pounds of Atlantic herring would count against catch caps in the shaded areas.



## SNE/MA RH/S Cap Closure Area

Closure Area (when 95% of the catch cap is reached)

Offshore statistical areas in SNE/MA would not be closed to directed herring fishery.



## FW3 RH/S Catch Caps 2014/2015

- RH/S catch caps specified/modified through Atlantic herring fishery specifications process
- Opportunity for coordinated cap with MA Council in future to address herring/mackerel fishery overlap
- GB catch cap considered in the future if necessary
