- > Draft Addendum I to Amendment 2 for the Northern Shrimp FMP also addresses total allowable catch specifications, allocation, fishery closures, gear restrictions, and research set-a-sides.
- Working with states and stakeholders on pending shark finning legislation.
- ➤ Initiated a petition to downlist/delist Atlantic Sturgeon and supported states in the development of section 7 and 10 applications.
- Initiated winter flounder addenda to change fishery measures in the Gulf of Maine, change the specification process, and propose accountability measures.
- Acting Executive Director testified, at request of House Natural Resources Committee, on H.R. 6096, the Atlantic Fisheries Statues Reauthorization Act, and H.R. 3096, a bill to amend the Atlantic Striped Bass Conservation Act to allow recreational fishing for Atlantic Striped Bass in the Block Island transit zone.
- Coordinated an additional follow-up Government Relations Workshop for Governor and Legislative Appointees in October to build on initial workshop in February.
- Coordinated with GSMFC and PSMFC on national legislation. Coordinated unprecedented Three-Commission Position letter on FY13 Appropriations and secured, through assistance from State Commissioners, seven signatures on House letter supporting increased funding for IJF and sustained funding for Councils and Commissions.
