

# Goal/Objectives

Provide an efficient management structure to implement coastwide management goals in a timely manner

Objectives:

- 1) Flexible management system
- 2) Promote cooperative collection of biological, economic, and sociological data
- 3) Manage to protect both young individuals and established breeding stock.
- 4) Develop research priorities to maximize the biological, social, and economic benefits



# **Recreational Measures**

- Status quo, Current state measures, Public Comment
- ≻ Minimum size: None to 32"
- ≻ Slot Limit: None, 10-30" Min.; 24-48" Max.
- ≻Trophy Allowance: None or one
- ► Bag Limit: None to 15
- ≻Vessel Limit: None to 20
- ≻ Maintain current measures



# **Commercial Measures**

- Status quo, Current state measures, Public Comment
- ≻ Minimum size: None to 32"
- ≻ Slot Limit: None, 10-30" Min.; 24-48" Max.
- ≻Trip Limit: None to 10K lbs; bycatch %
- ≻Limited entry: None or a system
- ≻Maintain current measures



# Joint Dealer Amendment

- Intent is for more frequent electronic reporting to improve ACL tracking to avoid overages
- Approved for submission to the Secretary of Commerce in August (Gulf Council) and September (South Atlantic Council)
- Expected submission: Oct/Nov 2012
- Expected implementation: June/July 2013 (?)

# Joint Dealer Amendment

- Creates one federal dealer permit that will be required to purchase:
- Atlantic Dolphin-Wahoo
- South Atlantic Golden Crab
- South Atlantic Rock Shrimp
- South Atlantic Snapper Grouper (including wreckfish)
- Gulf of Mexico Reef Fish
- Gulf of Mexico and South Atlantic Coastal Migratory Pelagics
- Gulf of Mexico and South Atlantic Spiny Lobster
- Gulf of Mexico Red Drum

Currently no federal

Requires <u>electronic</u> weekly reporting, and dealer permit a "no purchase" form each week if the dealer did not purchase any of the above species.

# Spanish Mackerel in State Waters

In September the SAFMC passed a motion to ask that the ASMFC consider a requirement for state dealers to have a federal dealer permit to purchase Spanish mackerel from state waters.

This would affect dealers with only state permits who buy Spanish mackerel from fishermen who do not hold a federal SM commercial permit and who harvest SM in state waters.

# Spanish Mackerel in State Waters

-The SAFMC specified that the new federal dealer permit requirement also meant that any federally permitted vessel must sell to a dealer with the new federal permit  $\rightarrow$ 

any vessel with a federal Spanish mackerel commercial permit will be required to sell to dealers with the new federal permit, even if the fish were harvested in state waters.

Any dealer who purchases CMP species caught in federal waters will be required to hold a federal dealer permit.
